

Tommy's Tips Promotion Terms and Conditions

5. Prize(s)

Minor Prize 1:

There will be one Minor Prize 1 awarded each Wednesday for the duration of the Promotional Period.

Minor Prize 2:

'The Ultimate Meat Tray' from Meat at Billy's - \$100 voucher on your choice of quality meats

Number of Prizes: 28

Prize value: \$100

Major Prize:

A XXXX Brewery Tour for 10 people, 20 Stubby Coolers, Private in-house Cinema room to watch the NRL Grand Final on the big screen plus \$1000 Food and Beverage package.

Number of Major Prizes: 1

Prize value: \$2000

Total Prize Pool: Up to \$6,650

6. Entry Procedure And Selection Process

Stage 1

To be entered into the Promotion, Entrants must, during the Promotional Period, register for the Promotion by:

- Listening to 'Brisbane Live with Ben Davis' on Radio 4BC each Wednesday ; and
- Calling 13 18 73 when the 'Cue to call ' is aired

Each week, the first Entrant whose call gets put through to air will win **(Stage 1 Winner)**:

- **Minor Prize 1; and**
- **A chance to win Minor Prize 2.**

Stage 2

Entry to win Minor Prize 2 each week is only open to Stage 1 Winners.

To be in the running to win Minor Prize 2, the Stage 1 Winner of the week:

- will have the opportunity to put forward their tips in this week's coming NRL round.
- Tips for that week's round of NRL must be submitted by the Stage 1 Winner on the same day as winning the Minor Prize 1, and prior to the commencement of the first game of the round.
- At the end of the round, the tips by the winner of the Minor Prize 1 will be compared to Tommy's tips for the week.

If the Stage 1 Winner's NRL Tips for that week beat or tie with Tommy Raudonikis' tips they will win **Minor Prize 2**. If the Stage 1 winner's winning tips are lower than Tommy's tips for the round, the Minor Prize 2 for that week will be forfeited and nobody will win the Minor Prize 2.

Stage 3

Stage 3 is only open to Stage 1 Winners (whether or not they were successful in Stage 2).

The Stage 3 prize is the Major Prize. There is only one winner.

At the end of the Promotional Period, the winner of the Major Prize will be determined at the Prize Draw Time by:

- Entering the names of the eligible Entrants into an online random number generator;
- The online generator will randomly select a winning number;
- The eligible Entrant whose name aligns with the number selected by the random number generator will be the winner of the Major Prize.

9. Prize Restrictions

Minor Prize 1 must be used on the date specified on the tickets. Failure to do so will result in the winner forfeiting the Prize and no alternative prize will be provided.

Minor Prize 2 must be used in one visit and any amount not redeemed in that visit or by September 28th 2019 will be forfeited.

10. Notification of Winners

11. Additional Terms
