

4BC Nine News Watch State of Origin Promotion Terms and Conditions

This is a Game of Skill. By entering into this Promotion, you (**Entrant**) acknowledge and accept the following terms and conditions, as well as the Promoter's general conditions of entry, as amended from time to time.

4. Entry Restrictions	<ul style="list-style-type: none">a. Entrants must be:<ul style="list-style-type: none">i. at least 18 years of age;ii. residents of QLD and NSW.b. Entrants must not be the employees (or their immediate family members) of:<ul style="list-style-type: none">i. The Promoter and its related bodies corporate; orii. The Prize Provider and its related bodies corporate.
5. Entry Procedure	<ul style="list-style-type: none">a. To be entered into Promotion, Entrants must, during the Promotional Period:<ul style="list-style-type: none">i. Watch the Channel 9 Brisbane 6pm news, where a winning codeword will appear on screen at some time during the news hour – the first codeword will appear on the Channel 9 Brisbane 6pm news on 20/06/21;ii. On the day after a codeword is shown, listen to Neil Breen 4BC Breakfast and wait for the cue to call;iii. Once the cue to call is aired on 4BC Breakfast, call 131 873;iv. The nominated caller each day of the Promotional Period will be given the opportunity to win a Prize;v. If the entrant is the nominated caller, they must correctly state the codeword that appeared on the news on the previous night while on the air. It must be the first codeword mentioned. No additional "guesses" will be allowed.

By entering the Promotion, the Entrant accepts and agrees:<ul style="list-style-type: none">i. to these terms and conditions;ii. to the Promoter's General Terms and Conditions of Entry; andiii. to the Promoter's Privacy Policy, available on the Promoter's website, and each of which may be amended from time to time by the Promoter (subject to the conditions of any permit).b. Participants consent to their personal information (as that term is defined in the Privacy Act 1988) being used for direct marketing by the Promoter and Prize Provider, distribution by the Promoter and uses approved in the Privacy Policy.c. Throughout the Promotional Period the Promoter may contact Entrants to interact with the station on air, online and via social media in relation to the Promotion.d. The Promoter will not disclose personal information to any entity outside of Australia.

- e. If a Prize is unavailable for any reason, the Promoter, at its discretion, may substitute it for another item of equal or higher value. The Prize is subject to any Prize Restrictions specified above. All Prize values stated are the recommended retail value as provided by the supplier, are in Australian dollars and are correct at the time of preparation of these terms and conditions.
- n. All Prizes and parts of the Prize are subject to availability, non-transferable and non-exchangeable, must be used on or by any dates specified in these terms and conditions and as stipulated by the Prize Provider and are not redeemable for cash unless cash is specified.
- o. Unless otherwise stipulated in this agreement, if the Prize must be used on a specific date (Expiry), and the Winner is unable to use it on that date, the Winner will forfeit the Prize and the Promoter may select a new winner in its absolute discretion on or before Expiry.
