

#### **4BC's Know The Show Promotion Terms and Conditions**

This is a Game of Skill. By entering into this Promotion, you (**Entrant**) acknowledge and accept the following terms and conditions, as well as the Promoter's general conditions of entry, as amended from time to time.

<b>4. Entry Restrictions</b>	<p>a. Entrants must be:</p> <p>i. at least 18 years of age;</p> <p>ii. residents of Queensland.</p> <p>b. Entrants must not be the employees (or their immediate family members) of:</p> <p>i. The Promoter and its related bodies corporate; or</p> <p>ii. The Prize Provider and its related bodies corporate.</p>
<b>5. Entry Procedure</b>	<p>a. To be entered into Promotion, Entrants must complete the following steps during the Promotional Period:</p> <p>i. On each weekday, listen to '4BC Breakfast', the 'Morning Show', '4BC Afternoons' or '4BC Drive';</p> <p>ii. Listen for the program's host to read the "Ekka" interesting fact;</p> <p>iii. Wait for the host to read out an "Ekka" question later in the show;</p> <p>iv. When the question is read, call the nominated contest phone number. In Breakfast, Afternoons and Drive, the number is 133 882, in the Morning Show only, the number is 1300 722 873. The nominated caller will be asked to answer the question, which will relate to the interesting fact read earlier in the program.</p>
<b>6. Selection process</b>	<p>a. The Winners of the <b>Prize</b> will be determined as follows:</p> <p>i. Each valid entrant who answers the question correctly will win the prize.</p> <p>ii. If the valid entrant answers the question incorrectly, the host will take additional calls until the correct answer is provided and the prize is won.</p> <p>The Promoter may select additional reserve entries and record them in order in case an invalid entry or ineligible entrant is selected.</p>
<b>7. Maximum Entries per person</b>	Entrants can attempt to enter by calling as many times as they wish, however they can only play to answer a question once.

<b>10. Prize Restrictions</b>	<p>Prize restrictions:</p> <p>a. The Prize is subject to any additional terms and conditions imposed by the Prize Provider.</p> <p>b. By entering, the winner understands they need to redeem their voucher for tickets via the Ekka Website (<a href="http://www.ekka.com.au">www.ekka.com.au</a>) and attend on the specified day.</p> <p>c. <b>11. Notification of Winners</b>	<p>a. The Winner's name will be announced on air on each Selection Date.</p> <p>b. The Winner will receive notification by phone and email.</p>

Participants consent to their personal information (as that term is defined in the Privacy Act 1988) being used for direct marketing by the Promoter and Prize Provider, distribution by the Promoter and uses approved in the Privacy Policy.</p> <p>c.
