4BC's Bunny Money Promotion Terms and Conditions

This is a Game of Chance. By entering into this Promotion, you (Entrant) acknowledge and accept the following terms and conditions, as well as the Promoter's general conditions of entry, as amended from time to time.

4. Entry Restrictions	a. Entrants must be: i. at least 18 years of age; ii. residents of Queensland iii. Entrants must not be the employees (or their immediate family members) of the Promoter and its related bodies corporate, or associated companies.
5. Entry Procedure	 a. To be entered into Promotion, Entrants must, during the Promotional Period, visit www.4BC.com.au and complete the online entry form, including their contact details, including (but not limited to) name, address, email address and phone number. b. 9. Prize(s)	Major Prize: \$1000 to be won each week day in the Breakfast show between Monday 20th March 2023 and Friday 31st March 2023. Prize consists of a \$1000 cash prize for providing the correct codeword.
	Minor prize: Consists of a \$100 Lindt voucher if they do not get the codeword correctly after answering.
	Bonus Prize will jackpot by \$1,000 if not correctly claimed in a particular contest. On the final week day, Entrants will continue to be called until a Winner is determined. Total maximum value of the prize is up to \$11,000
10. Notification and Publication of Winners	a. The Winner will receive notification by phone to the phone number provided at the time of entry.
11. Additional Terms	 a. By entering the Promotion, the Entrant accepts and agrees: i. to these terms and conditions; ii. to the Promoter's General Terms and Conditions of Entry; and iii. to the Promoter's Privacy Policy, available on the Promoter's website, and each of which may be amended from time to time by the Promoter (subject to the conditions of any permit). b. - p. A winner has rights under the Australian Consumer Law and other similar legislation which cannot be excluded, restricted or modified by the Promoter. These rights include a statutory guarantee that any services provided by the Promoter will be rendered with due care and skill and that any goods will be of acceptable quality. These Conditions of Entry do not exclude, restrict or modify those statutory rights in any way.
